PUBLIC/COMMUNITY RELATIONS:

Carol-Lynn Dubovi, New Sewickley Township, asked if a technology needs
assessment was being conducted at the High School. Dr. Fuller responded that one
should be completed by this spring outlining options for the District to address.

SUPERINTENDENT'S REPORT:

Dr. Fuller, Superintendent, reported on the following:

The Polar Plunge held Saturday, January 24, 2015 was a huge success. Team Freedom raised over \$5,200 and approximately \$84,000 was raised county-wide for the Beaver County Special Olympics. The Elementary Schools won the Team Freedom Traveling Trophy for the donations received from Freedom students and staff, bringing in over \$1,250.

LEGISLATION:

Dr. Fuller, Superintendent, gave the Legislative update saying the Legislature is back in session and the House Education Committee is pushing ahead very quickly on a number of issues. Some are very positive moves that we can hope make it through both houses quickly.

During the meeting in Harrisburg last week, we met with the new chairmen of both the House Education Committee (Rep. Stan Saylor, R-York) and the Senate Education Committee (Sen. Lloyd Smucker, R-Lancaster). Rep. Saylor has not served on the Education Committee previously. He has actually been moving the Committee pretty quickly, having reported out four bills last week and several more anticipated to be reported out in the next few days.

Bills – HB 127 and HB 139 – will likely be passed by the House today and moved on to the Senate for consideration.

- <u>HB 127</u> amends the School Code to require a school entity to make available upon request to armed forces recruiters a list of 11th and 12th grade students and to notify all 10th and 11th graders and any 12th graders not yet 18
- <u>HB 139</u> amends the Private Academic Schools Act to allow online schools to become licensed by the State Board of Private Academic Schools

Bills – HB 210, HB 168, and HB 177 – are very important. It is strongly suggested that all Board Members (and their friends!) contact your local representative and encourage their support of each of those bills.

- <u>HB 210</u> amends the Public School Code to streamline and automate the PlanCon process, make changes to some of the current criteria, create a transparent website to determine project status, allow lump sum reimbursement with the approval of PDE and the school district and allow districts that engaged in construction projects during the moratorium to remain eligible for reimbursement. <u>NOTE:</u> This bill is similar to legislation introduced last session. It basically streamlines and automates the program (i.e. decreasing the 11-step process to a 5-step process).
- HB 168 amends the Public School Code to eliminate all Keystone Exam subjects
 except Algebra I, literature and biology and prohibits the exam from being used as a
 statewide graduation requirement
- HB 177 amends the Public School Code to create an Academic Standards Commission, made up of the Education Committee chairmen, public school teachers and administrators, higher education representatives and members of the business community, to review and make recommendations regarding the PA Core Standards and issue a report within 18 months of its first meeting.
