# SUPERINTENDENT'S REPORT:

Dr. Fuller, Superintendent, reported on the following:

### Bomb Threats -

We have had several bomb threats over the last three weeks. Each of the threats were delivered by messages written on bathroom walls so we are confident that they are coming from a student. The threats received at the middle school are very clearly copycat activity following the threats received at the high school.

This is a very serious matter and we are using all means necessary to identify the persons involved. We have involved the local police agencies, Beaver County Emergency Management, the Federal Bureau of Investigation, and Forensic Handwriting Specialists to identify suspects.

When a suspect is identified, they will be prosecuted to the full extent of the law. This includes the filing of felony charges, the payment of restitution, and expulsion from school.

#### Relay For Life -

If you weren't able to join us last Saturday at the stadium for our Relay For Life event, you missed an amazing day! Our students set a fundraising goal of \$10,000 for the event. Mr. Deal and Mr. Smith agreed that if the students reached that goal, they would color their hair purple. That goal was met two days before the event started! So, I challenged the students to reach \$15,000 and that goal was met by mid-afternoon on Saturday. So, we raised the bar again. Mr. Deal and Mr. Smith agreed that if they reached \$20,000, they would each take a pie in the face from each team captain. There are 31 team captains. They also agreed that if the event reached \$25,000 by next Tuesday, they would stand under a bucket of slime. And we defined a bucket as the bucket of a front loader. After some negotiations with my wife, I also agreed that if the event reaches \$30,000 by next Tuesday, I would shave my head.

# Fed-EX Safe Driver Program -

On Monday morning, our junior and senior students had a great opportunity to participate in the Fed-EX Operation Safe Driver program. This national program travels to schools to teach students about the dangers of drunk and distracted driving. Students heard an impactful presentation from a young lady who was in a serious accident as a result of distracted driving. They also had the opportunity to safely experience what it feels like to operate a motor vehicle while under the influence. Students drove golf carts through a closed course while wearing impairment goggles. This program was brought to the district by our school resource officer, Mr. Tom Liberty of the New Sewickley Township Police Department. It is our hope that we will be able to repeat this program on an annual basis for our high school students.
