SUPERINTENDENT'S REPORT:

Dr. Fuller, Superintendent, reported as follows:

School Resource Officer (SRO):

The District entered into an agreement with the New Sewickley Township Police Department and secured a federal grant that enables the District to have a School Resource Officer on campus working with our students and staff on a daily basis. Last month the Board was provided with a report from our SRO, Officer Tom Liberty. He provided an overview of the projects he has been working on during his time with us and what he has planned for this school year. We have asked Officer Liberty to be with us this evening to talk to the Board and public about those plans for a few minutes.

Beaver County Career and Technology Center Citizen's Advisory Board:

Mr. Eugene Caputo and Mrs. Cynthia Matthews have agreed to continue to serve in their role as our representatives on the BCCTC Citizen's Advisory Board. We will look to the Board for a motion to approve their continuation in this role.

PIAA Ruling:

The PIAA (the state's ruling body that governs high school athletics) has voted to change the classifications for high school sports across the state. This action increases the number of classifications from 4 to 6 for football, boys' and girls' basketball, baseball and softball. They also voted to increase the number of classifications for boys and girls soccer, and volleyball from 3 to 4. These are drastic changes that will have an impact on every school district in the state.

In speaking with Mr. Rosa and based on the report that was reviewed, we do not feel that this will have a huge impact on the district. There will likely be about 23 districts in our classification in Western Pennsylvania. We may have to travel a little bit longer, depending on how the schools are subdivided and how the numbers fall, but the impact should be minimal.

Glade Run Lutheran Services / St. Stephen's:

Over the last few weeks there have been news reports related to alleged sexual abuse in a residential treatment facility housed at St. Stephens School in Zelienople. This afternoon it was reported that the Department of Human Services is ordering that this program be shut down within 30 days as a result of these allegations. Dr. Fuller assured the Board and public that while we do have a student who participates in the equarian program for parts of two days each week, the Freedom Area School District does not have any students enrolled in the program in which the alleged incidents took place. The District will continue to monitor the placements for each of our students to ensure that they are being treated appropriately and receiving the best possible educational programing to support their needs, regardless of their assigned placement.

Follow-Up on Last Week's Public Comments re: Smoking:

We heard from a member of our community last week regarding smoking on our campus, especially during athletic events. As follow-up to those comments, Dr. Fuller has worked with district staff to order "Tobacco Free Campus" signs that will be placed at appropriate locations around school facilities - including our facilities in Conway and Big Knob. This has also been communicated to our Law Enforcement partners saying our expectation is that the Tobacco Free Campus ordinances will be enforced. The concern we have is that the surface streets around the stadium are not district property, so the smoking ordinance cannot be enforced. Additionally, we do not provide law enforcement coverage for many events that occur in the stadium. However, Dr. Fuller has instructed the Athletic Director to communicate to those groups - both district-sponsored and community-based - that we expect them to enforce the tobacco free campus restrictions during their events.
