SUPERINTENDENT'S REPORT:

Dr. Fuller, Superintendent, reported on the following:

School Performance Profile Release

Our teachers, students, and administrators have been working very hard for the last few years to bring about needed improvements in our academic programming. We have completely revised our instructional curriculum, provided updated instructional resources, provided intensive professional development, significantly updated our technology, and pushed our students to new heights. When I first met with the Board almost four years ago, our academic growth scores were very low - in the -64 to -86 range. This year, for the first time, our growth scores were in the green - overall, our students showed positive growth in their academic achievement.

As the Board and community is aware, the Pennsylvania Department of Education has released the School Performance Profile reports for the 2014-15 School Year. As a reminder, for the last 2 years, PDE has given each school in the district an SPP score that provides and overall rating of the school taking into account a number of important items - student achievement, student academic growth, attendance, and a number of other factors. Because of the well-publicized concerns with student assessment scores across the state brought on by the complete revision of the PSSA tests last spring, PDE applied to the federal Department of Education for a waiver. This waiver was granted for K-8 schools. That means that districts only received an SPP score for schools that serve 11th grade students.

In 2013, our high school received an SPP of 67.7. In 2014, we had an SPP score of 69.1. This year's SPP scores were released to the public yesterday. Following the pattern shown in growth scores, this year's School Performance Profile score is a 72.2, a very positive improvement. We still have a lot of work to be done. However, the results we are seeing now show that the work of our students, staff, and administrators is paying off and we are moving in the right direction.

National Title I Distinguished School

Another sign of that improvement was seen in the letter that we received from the Division of Federal Programs this week. We have been notified that for the second year in a row, our elementary program is eligible to be identified as a National Title 1 Distinguished School. I have asked Mrs. Slavic to give the Board an overview of the elements of this nomination and any requirements that may be required if we are selected to represent the state this year.

FACILITIES MASTER PLAN:

Scott Smith, Construction Representative, gave a construction progress update saying the Contractors have revised the punch list and it is in process for completion. No final date for completion at this time.
