SUPERINTENDENT'S REPORT:

Dr. Fuller, Superintendent, reported on the following:

<u>State Budget Update</u>: Gov. Wolf and legislative leaders have announced that they have reached agreement on what is being called a "tentative framework" for a new state budget. They hope to have the details worked out so that a budget bill can be on the Governor's desk for signature before Thanksgiving, but there are still a lot of details to be worked out.

The agreement calls for an increase in basic subsidy for public education of \$350 million, with an additional \$50 million increase for special education. The Governor was originally requesting \$400 million for basic education and \$100 million for special education. The special education funding will be driven out to districts using the funding formula that was put in place last year. There has been no determination as to how the \$350 million in basic education funding will be driven out to districts.

The bill also includes a 1.25% hike in sales tax, moving that from 6% to 7.25% (8.25% in Allegheny County). This would generate \$2 billion to be used for property tax relief. Again, there is no agreement on how these funds will be driven out.

There will also likely be pension reform for future employees tied to the bill. This will likely be a hybrid plan that includes components of both a defined benefit plan and a 401(k)-style defined contribution plan.

The other important component of the plan is that the Senate is looking to vote on SB 76 - the "Property Tax Independence Act" - that eliminates property tax and shifts the funding of public schools to a variety of other taxing mechanisms, including sales tax and personal income tax. This bill the potential to be very damaging to public schools because it will completely shift the funding of our schools to the state, taking away any local effort or responsibility, but also making schools subject to the political whims of those in Harrisburg.

2016 Board Meeting Calendar: The proposed meeting schedule for our 2016 Board meetings is at your place. As discussed, the proposed schedule takes us to a one meeting a month schedule. We will always have the ability to advertise and schedule additional meetings, as needed. With the exception of March and April, the meetings are scheduled for the 2nd Thursday of the month. Let me know if there are any questions or conflict. We will be prepared to approve it in December. Mrs. Leindecker and Mr. Inman will also have an opportunity to review the schedule prior to next month's meeting.
