SUPERINTENDENT'S REPORT:

Dr. Fuller, Superintendent, reported on the following:

<u>- State Budget</u> - We still do not have a budget. It does appear that there is movement in the House to remove Rep. Turzai from power, giving hope to the budget process. However, we still have nothing concrete. As you know, not having a state budget makes it very difficult to both operate the district and to plan for next school year's budget, a preliminary proposed version of which you will be asked to approve this evening.

The Governor has said that he will not sign any budget that does not include reforms to the retirement system. Given that we are 162 days into this fight, it is clear that the Governor has decided that he is going to fight for a budget that he feels is right, even if it costs him the next election.

ESEA - The ESEA of 1969 - more commonly known as the No Child Left Behind act - was finally reauthorized this week. The new version of the act is called the "Every Student Succeeds Act". It is now on the way to President Obama's desk for signature, which is expected before the end of the month. The overview is that, while the Act still requires testing of students in grades 3-8 and once in high school, there is significantly more flexibility given to states in all areas of education. This reauthorization is seen as a clear win for states and for public education, as it

significantly reduces the role of the federal government in the operation of our schools and in the areas of testing and accountability.

- Update on Staff Clearances - The legislature changed the law regarding the requirement for clearances for all staff members and volunteers that are in direct contact with children. The new law requires that all individuals have updated clearances on file before the end of December 2015 in order to maintain their position. We have been working diligently with our staff over the course of the last year to get their clearances updated, sending reminders and providing trainings. The Tuesday before Thanksgiving, each person who has not turned in updated clearances received a personal visit from me. At that time we had 115 folks who needed at least one clearance update. As of today, there are still 31 employees who need at least one updated clearance. The vast majority of those are coaches of sports who are out of season. Additionally, many of those 31 have reported that their clearances are in process. Our plan is to send a very strong reminder to those who have not submitted updated clearances tomorrow. They will be reminded of the requirements of the law and informed that if they do not submit their updated clearances as required by law, they will not be permitted to have contact with students when we return to school in January. They will be directed to report to Central Office, where an informal hearing will be held on January 4th. If the clearances are not provided, they may be subject to immediate suspension without compensation. If they continue to fail to supply the updated clearances, they may be subject to dismissal from employment. It is our hope that all employees will have the appropriate clearances updated, but we are subject to the law and will take the actions necessary, especially since the district has been very proactive in providing reminders and resources to assist in completing this process in a timely manner over the course of the last year.
